**THE PREZ SEZ****Martha Roblee**

Although the focus of this month's President's letter is to provide a debrief on the recent election, I would like to begin by echoing the sentiments recently expressed by our National League President Elizabeth MacNamara – **"if you voted this year or helped others in your community cast their votes, thank you!"**

From my perspective the biggest takeaway from this year's midterm elections is the historically low voter turnout. Various media outlets reported nationwide turnout of 36.6%, the lowest since WWII, and exit polls showed only 13% of the voters were under 30. In South Carolina, the State Election Commission reported a statewide turnout of 43.6% of registered voters – better than the national average, but still the lowest in at least 40 years for a general election in South Carolina and approximately 8 points less than the 2010 election. The number of South Carolina voters under the age 30 has not been officially reported, but exit polling indicates a 10% turnout, much worse than the national average.

These statistics can be disheartening to members of the LWV, whose volunteers work tirelessly to register new voters, with a special focus on young people and newly naturalized citizens. We also work hard to provide nonpartisan information on candidates through debates, forums, and online voters' guides, and in some cases, serve as poll workers and poll monitors. The positive news is that we can count on the League to take a leadership role to conduct further analysis of the election results in order to identify what actions can be taken to better engage eligible voters.

To that end, I recently attended an election debriefing meeting of the South Carolina Statewide Voter Advocacy Partnership ("SCVAP"), an initiative sponsored by the State League. With our partners we discussed what went right and what can be improved.

Topics discussed included understanding the impact on the elections resulting from gerrymandered districts, the number of provisional votes cast due to recurring issues with the DMV's processing of voter registrations and changes in address, confusion caused by changes in precinct locations, accessibility issues experienced by voters with disabilities, and the cynicism expressed by young voters believing their vote does not matter. Although there are no easy answers to many of the barriers identified at the meeting, for the short-term it was agreed that working subcommittees could be formed to address the DMV processing issues and the accessibility issues experienced by disabled voters. Longer term action is most likely required, however, to address such issues as the deadline date for voter registration and how best to engage younger voters.

What I do know is how vital the League and its volunteer members are to the voting process and how grateful I am that the League provides me with the opportunity to participate in initiatives such as the SCVAP. It is those types of investments by our members and partners that will make our Democracy work better in the future by helping us to build on the successes and fix the issues.

## **Public Policy Luncheon November 20, 2014 Recap – Pam Craig**

Pat Forbis introduced our guest speaker, Melissa Reed, VP for Public Policy and Executive Director, Planned Parenthood Health System and Planned Parenthood of Central North Carolina Action Funds. Approximately six years ago, Ms. Reed came to Planned Parenthood Health System, whose name will soon change to Planned Parenthood South Atlantic, encompassing South and North Carolina, West Virginia and part of Virginia, to continue her fight to defend the rights of those less fortunate, as she had done in the past working for an organization protecting battered women. To add to her credentials, Ms. Reed recently passed the North Carolina bar.

Ms. Reed spoke to us of what we might see in upcoming S.C. legislation. South Carolina, under the sponsorship of Senator Lee Bright, is considering laws similar to those in Texas which were requiring abortion clinic doctors to have certification and hospital admitting privileges. Though this law was struck down in Texas, Ms. Reed anticipates the possibility that Senator Bright might do some tweaking and reintroduce the bills. The refusal of our Governor to expand Medicaid under the Affordable Care Act, also known as Obamacare, is another roadblock to limiting women's access to affordable healthcare, including birth control. It is estimated that 99% of all women use some form of birth control at some stage in their life, and, yet, the average female pays approximately \$600 in out of pocket expenses per year. That should be compared with FREE Viagra.

One of the biggest threats to women's reproductive choices was the recent Hobby Lobby decision. In this decision, the U.S. Supreme Court ruled that family-owned corporations are no longer required to pay for insurance coverage for contraception under the ACA, stating that it violated a federal law protecting their religious freedom. Ms. Reed warned that this decision could open the doors to many challenges from corporations over laws they claim violate their religious freedom (e.g., blood transfusions or vaccinations).

When you add in the U.S. Supreme Court decision striking down the Massachusetts' law that provided 35-foot buffer zones around entrances to clinics performing abortions you begin to sense that women themselves are under attack. If you throw in laws limiting abortions at 20 weeks and attempts to pass bills that give fertilized eggs the same rights as individuals, the barrage to regulate women's reproductive rights seems relentless. For that reason, Melissa and others like her are our troops in the battlefield called the State House.

The troops are preparing for a battle, once the legislation is in session, to support a bill that requires sex education to be medically accurate and to provide a definition of what is "medically accurate". Let's hope it doesn't fall in line with "minimally adequate" because that could mean a twenty year fight.

As part of the fight, in March, PPH will have their fund raiser. It's an award ceremony in honor of Barbara Moxon, an advocate of Planned Parenthood and former League president, so keep your calendar clear and be ready.

## ENVIRONMENTAL ISSUES:

### ENVIRONMENTAL UPDATE: By Chester Sansbury, Environmental Coordinator

#### Our Small Creeks Are Valuable – and our students will be teaching us!

Small creeks that flow through our neighborhoods serve a very useful purpose. They provide serenity, habitat for aquatic dependent creatures, and receptors for storm water. They also aid in flood prevention, are a great place for kids to play and explore our natural world, and enhance property values. I'm glad to see that students at Leaphart Elementary school in my Lexington County neighborhood will be studying Kinley Creek watershed after being selected as a DHEC Champions of the Environment grant winner. The Creek drains areas around Irmo and Harbison and passes next to Whitehall subdivision, an area of over 1200 homes, passes under St. Andrews Road, meanders through a conservation area next to Shaw Industries, and connects to the Lower Saluda River. Perhaps the students will be able to discover some sources of pollution in the watershed which cause bacterial levels to skyrocket in the Creek after storms. Here's some info from the DHEC web site about the approved project:

Students will take part in the development of a [Watershed Based Plan](#) for the Kinley Creek Watershed. First, an existing conditions inventory will be performed to study the natural history of the watershed, and maps will be created to illustrate land use, land cover, flood plain boundaries, stream networks and storm water infrastructure. Next, students will implement storm water management practices such as harvesting rainwater, creating rain gardens, and conducting public awareness campaigns. Finally, students will design and develop interpretive materials for placement at Seven Oaks Park and Leaphart Elementary School.

Leaphart Elementary School, an engineering magnet school, will partner with the Central Midlands Council of Governments, Irmo Chapin Recreation Commission, and Lexington and Richland Countywide Storm water Consortiums. This partnership will enhance Leaphart's engineering based curriculum by giving students the chance to work on a real world civil and environmental engineering project alongside environmental professionals.


