**THE PREZ SEZ***Martha Roblee*

On August 21, we held our annual Summer Member & Guest Social. The turnout was great, including 6 guests. My thanks to those members who extended invitations to friends and associates and to Janie and Robin White, Carol Medich, and Al Roblee for helping with set up. We have a great organization and the Summer Social is one way we can make the public aware of what the League does while increasing our membership. Read Pam Craig's article on [page 7](#).



I told our members and guests at the Summer Social, the LWV of the Columbia Area will be focusing on two main areas this year – 1) voter services and 2) engaging our members to answer a “call for service.”

This is an important year for the Voter Services Committee with the November mid-term elections fast approaching. This is the first “real test” of the recently enacted voter photo ID rules. Adding to the potential confusion at the polls arising from the new rules, is the creation of a large number of new precincts in Richland County and distrust by the voters caused by long waiting lines during the 2012 elections. Adding to the voters' distrust are the lawsuits and legislative action relating to the merger of county voter registration and election boards, the resignation of the newly hired Director of the Richland County Voter Registration & Elections Board, and the slow progress of the Richland County Legislative Delegation to appoint new members to the newly merged Richland County board. Voters in West Columbia and Chapin will also get to decide on how strong of a Mayor they want for their cities, and Lexington County voters will be faced with a very lengthy ballot due to a penny sales tax referendum to fund roads and highways.

Many thanks to Mel Jenkins for stepping up and assuming the chairperson role of the Voter Services Committee in this hectic mid-term election year. He is a great example of truly answering the “call for service.”

To address this environment, Mel and his committee will develop a plan and set goals for providing as many Columbia area voters as possible with accurate, timely and useful nonpartisan information on candidates and basic registration and voting rules and process. Already in the planning stages is a Richland District 2 School Board Candidates Forum. Sally Huguley is taking the lead to organize the forum.

The LWVCA has also agreed to be a partner in an important voter advocacy network initiative sponsored by the State League. The LWVCA is responsible for Region 4, which includes Richland, Lexington, Aiken, Edgefield, Barnwell, Bamberg, Orangeburg, and

Calhoun counties. Our short-term goal is to offer regional voter education meetings in partnership with local voter advocacy groups to educate voters regarding voting laws and their rights, to register voters, and to involve voters with the election process in their counties.

As you can see we are going to need your help! If you would like to be a member of the Voter Services Committee or assist the committee in anyway, please see Mel.

This is a perfect segue into the second area of focus. Since the League is a volunteer organization that tackles important public policy issues and carries out a variety of election-related services, it is necessary to have members actively participate to enable us to accomplish our League's goals. We are asking members to identify a job – See the available jobs list on [page 5](#) and let me, any member of the board, or a committee chair know how you would like to work for the changes you want. ***The League is You – A Call for Service!***

I look forward to seeing you at our September PPL. Our guest speaker is Carla Damron who will give us a timely presentation about the homeless issue in the Midlands.

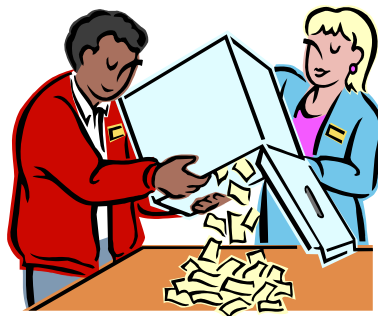

## **THE LEAGUE IS YOU – A CALL FOR SERVICE!**

Since the League is a volunteer organization that tackles important public issues and carries out a variety of election-related services, it is necessary to have members actively participate to enable our League to accomplish its goals. Members have the opportunity to get involved at all levels of commitment. We understand that, due to time and resource limitations or just because you are new to the League, you may be able to volunteer for only one task for one event or activity that may require no more than a few hours of your time. Others are able to give more time and may serve as a committee chair or on the board. No matter what the level of commitment you can give, there is a job or task in which you can get involved.

If you don't see something on the below list that you would like to do, please do not hesitate to contact a member of the board, the Volunteer Coordinator, or a committee to discuss your thoughts. Maybe we just haven't realized the role you could play, the skills you could contribute, or your particular interests.

Change cannot be made without hard work. If you have joined the League to make a change, please identify a job [from the list below—or another that you think is needed] and let us know how you would like to work for the changes you want. Please note that training will be provided as needed.

### **HOW YOU CAN VOLUNTEER:**

**Caller** – Call new members to welcome them to the League; call members who have not been recently active and invite them to an upcoming event or activity; call members with regards to a specific event, activity or public policy issue (e.g. attendance at events on short notice or member socials, action alerts), or for survey purposes.

**Facilitator** – Facilitate a consensus or program planning meeting; a facilitator keeps the meeting group on task so that objectives are achieved within the time allotted.

**Greeter** – Welcome guests and/or greet members at events - guide new members and guests through the initial procedures, hand out brochures or direct to seating.

**Moderator** – Moderate a candidates meeting or debate or public information forum.

**Observer Corps** – Attend a governmental meeting (e.g., city or county council meetings or committee meetings, including special legislative sessions as identified by the board), note what happens at the meeting, and report back to the League.

Time Keeper – Serve as a timekeeper for candidate meetings or debates or public information forums. The role of the timekeeper is to make sure that each candidate/speaker does not go over the time allotted for each question, rebuttal, and opening and closing statements to provide equal time for all to speak.

Writer – Write an article reporting on a League event or activity to include the “who, what, where, when, and why” of the event or activity.

Voter Services – Volunteer to register voters at one or more community events, schools, or colleges; pick up, copy, and/or distribute voter information to members who volunteer to work at a voter services activity.

Recorder – Take notes at a consensus or program planning meeting, including any official decisions and actions taken.

Committee Member – Serve as a member on a committee formed to plan and conduct a “one-time” event (e.g., member social, consensus meeting, or public information forum) or serve as a regular committee member on the Voter Services, Membership, League Outreach or Communications committee or one of the public policy committees.

Development – Use contacts or make fundraising calls; make a contribution to the League; assist with a fund raising event.

Outreach – Identify and use media contacts and other groups or allied organizations to increase the League’s visibility in the Columbia area and to get stories/events/activities carried by the television, radio, print and electronic media.

Archivist – Research and propose document storage software program to board for approval to purchase; implement software; organize and scan League documents, and ensure their proper disposition at end of League fiscal year or on other designated schedule. Coordinate with USC Special Collections director for receipt of League papers for the Political Collections Library.

## SCHOOL DISCIPLINE: CLASSROOM TO PRISON?

Across America, the schoolyard massacre of children by their classmates has led to "zero tolerance" disciplinary policies and the incorporation of School Resource Officers in our schools. But a growing body of research shows that the effect of this new discipline has cast a much wider net than originally intended. This net has trapped a disproportionate number of minority children in the criminal justice system. Many times their offenses are youthful indiscretions that had been previously handled in the principal's office. The result is often devastating to the child, their family and to the community.

**THE MIDLANDS TRANSIT RIDERS ASSOCIATION (MTRA)**, will hold its upcoming General Membership meeting September 13<sup>th</sup> at the Richland County Main Branch Library, located at 1431 Assembly Street in the Bostick Auditorium, from 2-4 p.m. Meeting agenda items will include, but will not be limited to, issues pertaining to upcoming improvements in the route and fare structures, increased route times, as well as other improvement that your MTRA has achieved for you. Also future improvements in the increased routes that the MTRA is working to achieve by the beginning of 2015.

MTRA is in the process of partnering with the Richland County Public Library, which has been very supportive in aiding the bus system so that bus riders and their families will have better access to more of the Richland County Libraries. It is for this reason that a

representative of the Richland County Public Library System will be making an important presentation to those present at the meeting.
